

VSA - LFS Platinum

Available only on L/Certified vehicles. **Reminder - please verify vehicle is certified with certification number, prior to selling supplemental VSA coverage.** If VSA Plan is purchased prior to the expiration of the manufacturer's warranty (less than 4 years and 50,000 miles from DOFU), the AGREEMENT EFFECTIVE DATE is the date the vehicle was first placed in service as a new vehicle. If purchased after the expiration of the manufacturer's warranty (greater than 4 years or 50,000 miles from DOFU), the AGREEMENT EFFECTIVE DATE is equal to the VEHICLE PURCHASE DATE. **YEARS are counted from the L/Certified Limited Warranty expiration and MILES are unlimited.** The VSA is available for purchase prior to the L/Certified Limited Warranty expiration.

Eligibility of L/Certified Limited Warranty Vehicle:

- Vehicle must be within current plus 6 model years old
- Total vehicle mileage at the time of retail sale or lease cannot exceed 70,000 original vehicle miles

Ineligible vehicles include taxis, shuttle, commuter, municipal, professional, medical, emergency or police vehicles, salvage vehicles, all vehicles used or to be used for competitive driving or racing, vehicles used or to be used for plowing snow or towing a trailer in a manner exceeding manufacturer's recommendations, and all vehicles to be held by the purchaser or lessee for hire to the public or for hire to any persons not affiliated with the vehicle purchaser or lessee.

- Protection from covered repair costs due to mechanical breakdown after your vehicle's warranty expires and up to the selected time/mileage option
- 24/7 Roadside Assistance
 - Coverage is effective throughout the life of the Agreement
 - Includes towing, flat tire, lockout, jump start and fuel delivery services
- Up to \$50 per day for car rentals or other substitute transportation for a maximum of 5 days per occurrence
- Up to \$100 per day for lodging and meals if customer is more than 150 miles from home for a maximum of 5 days over the life of the Agreement
- Agreement is transferable one time without a processing fee
